II. Sanitary Sewer

- A. Goals:
 - 1. Professional collaboration regarding a public sanitary pump station and force main
 - 2. Minimize cost through collaborative planning and financing solutions
- B. Two Step Process
 - 1. City to provide PBS team with applicable data and reports regarding recent sanitary sewer pump station and force main design and costs.
 - 2. City and School District teams to meet to discuss financing solutions including: SDC credits, latecomer agreements; Municipal Code amendments, development agreements

III. Streets and Traffic

- A. DKS will review and comment on information provided at meeting
- B. General impressions at this stage are:
 - 1. Right turn lane may not be warranted
 - 2. PBS will request school speed zone signs
 - 3. City will consider speed reduction based on speed study
 - 4. Lockwood Creek Road to be designed as 3 lane minor arterial
 - 5. PBS will design concept level solution to meet safe walking and biking to schools goals
 - 6. City will charge TIFs based on formula DKS will provide considering existing trips and a cap on future trips
 - 7. Frontage improvements to Lockwood Creek Rd consistent with the adopted CFP and 6-year CIP may be creditable

IV. Timelines

- A. Naomi to schedule follow-up joint team meeting within 10 days +/-
- B. PBS anticipates two weeks until ready to submit land use application
- C. City will review land use application for technical completeness (TC) while the PBS team prepares preliminary plans but cannot conduct SEPA review and schedule hearing until the application is TC.
