

DETERMINATION OF NON-SIGNIFICANCE (DNS) Old Steenson Boats and United Salvage Property Grading Permit (File # 2017-002-SEPA)

Description of proposal: The project will: remove existing buildings and approximately 8,200 sq. ft. of asphalt; decommission a well; grade approximately 53,143 Sq. Ft. to match the contours of the adjacent Cowlitz Tribal casino; balance 2,278 cubic yards of cut with an equal amount of fill; and plant grasses. Stormwater will flow to the existing stormwater pond on the casino site. The two parcels were previously used as a gas station and a clean-up effort related to contaminated soils and underground storage tanks was completed in the 1990's under Ecology review. The project will not impact critical areas or shorelands. Clark County indicates that the site has a moderate-high probability of containing archaeological resources.
