### Addendum #1

This addendum shows a revised bid schedule, changes to specifications items as listed below.

The following are the added items for the addendum:

- Replace the bid schedule in the current bid with the attached bid schedule.
- Section 1-10.4(2) shall be amended as follows:  
  
Construction Signs, Class B will be measured by each for each sign and will be paid as each.
- The below section shall be modified to remove the requirement of the contractor to remove the RPMs, and existing thermoplastic crosswalk striping and elimination of public notification.

#### **1-10.1 General**

- Section 1-10.1 is supplemented with the following:
- **Property Owner Notification**  
The city shall place flyers to notify residents of the chip seal. The contractor shall give notification of the schedule to the city to allow ample time to notify the residents. No new work will begin by the Contractor, until the notification period has elapsed.

#### **Notifications**

Notifications will be done by the city to all affected agencies and services including but not limited to the U.S. Postal Service, garbage services, recycling services, affected school districts, Police Department, Clark County Fire and Rescue.

- Notification shall be given to fronting properties by the City approximately fourty-eight hours (48 hrs.) prior to beginning work.

### **5-02.5 Payment**

Section 5-02.5 is supplemented with the following:

3/8" #4 Chip Rock, per square yard

PMCRS-2h emulsion, per square yard

The unit contract price per square yard shall be full pay for all costs of material, labor, tools, and equipment necessary for the application of bituminous surface treatment/chip seal, as specified. Preparation of existing surfaces, temporary pavement markings, sweeping\brooming as necessary, and temporary pollution and erosion control shall be included in these items.

If the bid exceeds such amount, the City has the right to reject all bids or the alternates to meet funding for the project. An equal number of alternates shall be added to the base bid of each bidder within funds available for purposes of determining the lowest bidder.
