Critical Areas Ordinance FEMA Code Updates (File #: 2023-027-ZON/SEPA)

The City of La Center is updating its code provisions pertaining to its Critical Areas Ordinance (CAO) for frequently flooded areas (LCMC 18.300.090[3]) per Federal Emergency Management Agency (FEMA) requirements. The purpose of the code update is to be in compliance with FEMA and Title 44 Code of Federal Standards (CFR) 59.1, 60.3, and 65.12 to ensure that citizens can participate in the National Flood Insurance Program (NFIP) and to ensure city compliance with NFIP requirements and flood hazard mapping. The code updates are including:

- Amending critical areas definitions (LCMC 18.300.030) to include dd new definitions and amend existing definitions as mandated by FEMA.
- Update prohibited uses in the special flood hazard area.
- Update permitted and exceptions to prohibited uses in the floodway and/or floodplain to match compliance with FEMA or CFR.
- Amending LCMC 18.300.090(3) for the permitting and/or prohibiting of the storage of materials and equipment in frequently flooded areas.
- Amending LCMC 18.300.090(3) to adopt by reference the updated Federal Insurance Rate Map (FIRM) panel that goes into effect November 2, 2023 with additions of area along Brezee Creek.
- Amending the responsibilities of the local administrator.
- Amending conditions for variances of historic structures in frequently flooded areas.

The hearing will be held on **Tuesday, September 12, 2023, beginning at 6:30 PM**. The City has modified the hearing and public testimony procedures to meet the Hybrid Meeting requirements. **The hearing will be conducted inperson at 210 E 4th Street La Center, WA 98629 and online via GoToMeeting (a video conferencing service).** Participants do not need internet access and can connect by phone.

The public is encouraged to provide written or oral testimony. Directions for participating are included under the "Remote Hearing Attendance and Public Testimony" section below.
