

DETERMINATION OF NON-SIGNIFICANCE (DNS) Wolverton Annexation and Rezone (File # 2017-008-SEPA)

Description of proposal: The applicants propose to annex 32.5 acres in seven (7) parcels into the corporate limits of the City of La Center. The project abuts La Center city limits and is located within the urban growth area. The city will apply a Low Density Residential (LDR-7.5) zone consistent with the La Center Comprehensive Plan land use designation.
