This is a non-project action for updates to Title 18 (Development Code) of the La Center Municipal Code (LCMC) to resolve inconsistencies in terminology pertaining to density. No additional phases of this project are anticipated.

The City of La Center is updating it's code to resolve conflicts pertaining to terminology for residential density. The following updates are proposed:

- Deleting LCMC 18.10.070 (Hierarchy of Plans and Regulations). Conflicts in code and city regulations will be resolved using 18.10.100 applying the most restrictive standard moving forward.
- Updating definitions in 18.40 including "density", and "net density", and inserting new definitions for "gross area" and "net area."
- Updating chapter 18.130 (Low Density Residential District) to include new locational criteria for the LDR-7.5 zone and eliminating the lot size averaging provisions that now allows lots between 6,750 and 6,800 square feet. The new proposed lot size minimum will be 7,500 square feet.
- Updating chapter 18.140 (Medium Density Residential District) to clarify that "beveled" lot sizes abutting low density residential districts shall be 90 percent of the minimum LDR 7.5 zoning district lot size or 6,750 square feet and clarifying that the minimum amount of landscaping provided shall be 15 percent of the net site area rather than gross site area.
- Revising chapter 18.150 (Commercial Districts) to specify that maximum residential density is 22 units per net acre rather than gross acre.
- Other minor clarifications regarding the term "units per acre."

The updates to the code are primarily changes to resolve inconsistencies in the terminology related to density and will not increase demands on transportation or public services and utilities.

The updates to the code are primarily changes to resolve inconsistencies in the terminology related to residential density and will not conflict with state or federal laws. The City's Comprehensive Plan defines density based on a gross acre basis, rather than a net acre basis that

is referenced in code A omprehensive plan amendment will be completed in 2021 to resolve this inconsistency and ensure the Comprehensive Plan references net density.
