



SEPA ENVIRONMENTAL CHECKLIST

This is a non-project action for an update to the City's sign code to allow electronic reader boards and digital video displays in residential zones on school properties and will be accomplished in a single phase. The city's Planning Commission reviewed the proposed updates and provided comment during their respective meeting on May 12, 2021.

A Public Hearing is also being scheduled on June 8, 2021 with the Planning Commission and another public hearing is anticipated on June 23, 2021 with the City Council.

Not applicable. This is a non-project SEPA checklist for an update to the City's sign code.

The City of La Center proposes to amend it's sign code to allow electronic reader boards and digital video displays in residential zones under very specific circumstances. The amendments primarily pertain to LCMC Section 8.60.060 and would remove the existing prohibition on electronic reader boards in residential zones under very specific circumstances including:

- *Signs must be located on a property of at least 10 acres used as a public or private school and only one sign is permitted;*
- *The sign shall be turned off from 9:00 p.m. to 7:00 a.m. seven days a week;*
- *Display size is limited to 16 square feet on each of two opposing faces;*
- *The sign must be located at least 150 feet from the nearest existing residence at the time of permit issuance.*
- *The sign must meet the general requirements for electronic reader board and digital video display signs except that size, hours of operation, and distance are regulated as per above.*

The proposed updates to the City's sign code to allow electronic reader boards and digital video displays in residential zones on properties of at least 10 acres used as a public or private school will not affect discharge to water, emissions to air; production, storage, or release of toxic or hazardous substances or production of noise.

Proposed measures to avoid or reduce such increases are:

Since the proposed update to the sign code will not affect discharges to water; emissions to air; production, storage, or release of toxic or hazardous substances; or production of noise, no mitigation is proposed or required.

2. How would the proposal be likely to affect plants, animals, fish, or marine life?

Generally speaking, the proposed sign code update would not affect plants, animals, fish, or marine life unless electronic reader boards and digital video displays were placed within wetland, fish and

wildlife, or frequently flooded critical areas. If placed in these areas light emitted by the signs may affect plants, animals, fish or marine life.

Proposed measures to protect or conserve plants, animals, fish, or marine life are:

The draft code includes a provision prohibiting electronic reader boards or digital video displays within wetland, fish and wildlife and frequently flooded critical areas or their buffers.

3. How would the proposal be likely to deplete energy or natural resources?

Any proposed electronic reader board or digital video display signs would be powered by electricity provided by Clark Public Utilities and may result in an incremental increase in energy usage. However, the increase would be so small in the context of region-wide or city-wide energy usage given strict limitations on the number of signs, size, and hours of operation, that they would not result in depletion of energy.

Proposed measures to protect or conserve energy and natural resources are:

Since electronic reader boards and digital video displays would have almost no effect on energy or natural resources, no mitigation measures are proposed or required.

4. How would the proposal be likely to use or affect environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection; such as parks, wilderness, wild and scenic rivers, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands?

The draft code includes a provision prohibiting placement of electronic reader boards and digital video displays within wetland, fish and wildlife, and frequently flooded critical areas or buffers. These types of signs could be placed in geologically hazardous areas and critical aquifer recharge areas subject to approval of a critical area permit in compliance with the City's critical areas ordinance (LCMC 18.300). Signs could not be placed in parks, wilderness areas, wild and scenic rivers (none in La Center), threatened or endangered species habitat, or prime farmlands. Placement of these sign types within historic or cultural sites would be subject to the City's archaeological protection code in LCMC 18.360.

Proposed measures to protect such resources or to avoid or reduce impacts are:

The draft code, if adopted, will prohibit placement of electronic reader boards and digital video displays in wetlands, fish and wildlife habitat, and floodplain critical areas and their buffers. Permitting of these sign types in geologically hazardous areas and critical aquifer recharge areas would be subject to the City's critical areas ordinance in LCMC 18.300. The draft code does not propose to change the provision of these sign types in parks. There are no wilderness areas or wild and scenic areas or prime farmland in La Center. Placement of these signs in historic or cultural sites would be subject to the City's archaeological protection code in LCMC 18.360. Therefore, no additional mitigations are proposed or required.

5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?

The proposed sign code amendments would allow electronic reader boards and digital video displays in additional locations within the City, specifically on public or private school properties of at least 10 acres in residential zones. However, only one such sign would be allowed for each school property. Therefore, the proposed sign code amendment would have almost no effect on the use of land within the City and none within shoreline areas.

Proposed measures to avoid or reduce shoreline and land use impacts are:

Since the proposed code will not affect land or shoreline use, no mitigation measures are proposed or required.

6. How would the proposal be likely to increase demands on transportation or public services and utilities?

Updates to the sign code to allow electronic reader boards and digital video displays on public or private school properties in residential zones, will not affect demand for transportation or public services. Demand for electricity may incrementally increase with the installation of such signs.

Proposed measures to reduce or respond to such demand(s) are:

The applicant will be required to serve the signs with electricity and and obtain electric service from Clark Public Utilities prior to turning the signs on. Obtaining Clark Public Utilities service is the obligation of the applicant. No mitigation is proposed or required.

To the City's knowledge, the proposed sign code update will not conflict with any local, state, or federal laws or requirements for protection of the environment.
