*The City of La Center is updating its code pertaining to family day care providers. The purpose of the code update is to permit family day care providers in residential dwellings in the city's residential and commercial zones in compliance with state law in Revised Code of Washington (RCW) 36.70A.450.*

*Family day cares would be subject to requirements including:*

- *Noticing to adjoining property owners;*
- *Compliance with building, fire, and safety codes.*
- *Obtaining a business license from the City and a license from the state;*
- *Conformance with zoning standards (lot size, building setbacks, lot coverage*
- *Providing parking and a passenger loading and unloading area*
- *Limiting hours of operation to 6:00 a.m. to 8:00 p.m.*

**D. Supplemental sheet for nonproject actions** [\[HELP\]](#)

1. How would the proposal be likely to increase discharge to water; emissions to air; production, storage, or release of toxic or hazardous substances; or production of noise?

*The updates to the family day care providers code are not anticipated to increase discharges to water or the production, storage, or release of toxic or hazardous substances. However, this update may incrementally increase air emissions and noise from vehicles traveling to and from family day care providers in the immediate vicinity of where they are located. Noise and emission impacts from a family day care provider are expected to be typical of what is expected for a residential neighborhood, but could marginally increase the amount of traffic to and from a neighborhood. These uses are typically sited in existing residential dwellings that were developed and approved through the City's zoning, stormwater, environmental, and noise regulations to minimize and mitigate any impacts.*

Proposed measures to avoid or reduce such increases are:

*A proposed measure to avoid or reduce increases to noise and emissions from family day care providers is to limit the hours of operation from 6 a.m. to 8 p.m.*

2. How would the proposal be likely to affect plants, animals, fish, or marine life?

*Applicants for family day care providers are typically sited in existing residential dwellings that were developed in compliance with the City's critical areas ordinance, SEPA regulations, stormwater regulations, shoreline ordinance, and tree protection ordinance, where applicable. These ordinances protect plants (in and outside critical areas), animals, and fish inside critical areas.*

Proposed measures to protect or conserve plants, animals, fish, or marine life are:

*Since the existing residential dwellings were required to comply with LCMC 18.300 (Critical Areas), LCMC 18.310 (Environmental Policy), LCMC 18.320 (Stormwater and Erosion Control), LCMC 18.330 (Shorelines), and LCMC 18.350 (Tree Protection) at the time of development, the proposed family day care providers are not anticipated to impact plants, animals, fish, or marine life., Therefore, no additional measures are proposed or required.*

3. How would the proposal be likely to deplete energy or natural resources?

*The siting of family day care providers may lead to a marginal increase in demand for water and electrical energy due to higher occupant loads within these residential dwellings for the care of children, however, the proposed code amendments would not affect the underlying demand for child care services. The residential dwellings the family day care providers are sited within would have been required to obtain electrical permits and service and water service through Clark PUD which has a comprehensive planning process to identify and plan for electric and water provision. Family day care providers would pay higher service fees if they use additional water or electricity. The marginal increases in use of water and energy are not anticipated to deplete energy or natural resources.*

Proposed measures to protect or conserve energy and natural resources are:

*No mitigation is proposed or required as part of the family day care providers code update since impacts on energy and natural resources would be marginal and Clark PUD can increase rates and has a plan to accommodate population growth that would lead to increased water and energy usage.*

4. How would the proposal be likely to use or affect environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection; such as parks, wilderness, wild and scenic rivers, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands?

*Any new developments in La Center are subject to the City's critical areas ordinance protecting wetlands, fish and wildlife habitat conservation areas, frequently flooded areas, geologically hazardous areas, and critical aquifer recharge areas prior to approval. Family day care providers would be sited within residential dwellings that were previously reviewed and approved under the City's critical areas ordinance. There are no wilderness areas or wild and scenic rivers in La Center. Threatened and endangered habitat is regulated by the City's critical areas ordinance. There is no prime farmland in La Center. Therefore, no impacts are anticipated for these resources.*

*City parks located close to family day cares may experience an incremental increase in usage, but such usage is not anticipated to exceed the park's capacity.*

Proposed measures to protect such resources or to avoid or reduce impacts are:

*No additional mitigation proposed. Future development of family day care providers will be reviewed for consistency with applicable federal, state, and city regulations. The City's approval of family day cares will include a requirement that they meet state licensing requirements prior to commencing operations.*

5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?

*The updated family day care providers code will allow these uses in existing residential dwellings that are already permitted in all of the City's residential and commercial zones. Family day care providers in these zones will be required to comply with the zoning regulations and use specific regulations that include, notification, parking, hours of operation, passenger loading, zoning, building, fire, safety, and licensing requirements. Therefore, family day care providers will not encourage land or shoreline uses incompatible with existing plans.*

Proposed measures to avoid or reduce shoreline and land use impacts are:

*Noticing to immediately adjoining property owners is required prior to obtaining state licensing for family day care providers.*

6. How would the proposal be likely to increase demands on transportation or public services and utilities?

*Family day care providers may generate traffic and may marginally increase use of the City's streets for vehicles traveling to and from these uses. The new code will require that the family day care provider have an adequate area for passenger loading and unloading, reducing impacts on public streets.*

*Family day care providers may generate an incremental increase in the use of the City's sewer utility due to increased occupant loads in residences, but increased demand is anticipated to be within the capacity of the City's sanitary sewer conveyance and treatment systems.*

*See response to section D.3 of this checklist for water and electricity utility impacts.*

*City parks may experience an incremental increase in usage, if family day care providers use these parks, but increased usage is not anticipated to exceed the capacity of these parks.*

Proposed measures to reduce or respond to such demand(s) are:

*Family day care providers are required to have an adequate passenger loading and unloading area to reduce impacts on local streets.*

*There would be no known conflicts with local state, or federal laws or requirements created by the proposed updates. Family day care providers would be required to comply with state licensing requirements prior to commencing care.*
