

NOTICE of Pre-application Conference NW Natural Telecommunications (File # 2018-018-CUP)

**Pre-Application Conference:** The City of La Center will conduct a pre-application conference on **Thursday, August 23, 2018 beginning at 11:00 AM** at the La Center Public Works Building, 305 NW Pacific Highway, La Center, WA 98629.

**Description of Proposal:** The applicant proposes to install a 30-foot wireless telecommunications tower (SCADA antenna) at an existing facility.

Location of Proposal: No site address. NW Spencer Road. PIN 211471000, #37 SEC 10 T4NR1EWM 0.014A (TCO 6-153) and 211471000, #38 SEC 10 T4NR1EWM 0.028A (TCO 6-150). Zoning: LDR 7.5 (low density residential).

**Approval Criteria:** The application will be reviewed for compliance with the La Center Municipal Code (LCMC): Titles: 13, Public Utilities; 15, Buildings and Construction, 18, Development Regulations, and the La Center Comprehensive Plan.

Central issues are:

- 1. Review Process: Whether to classify the use as a "Public Utility", a limited use in the LDR 7.5 zone and subject to administrative Type II site plan review, or a telecommunications facility, a conditional use in the zone subject to a Type III public hearing.
- 2. Variance: The maximum building height allowed in the LDR 7.5 district is 35 feet. The maximum accessory structure height is 12.5 feet.

Applicable Title 18 requirements include chapters: 18.30 Procedures; 18.40 Definitions, 18.130 Low Density Residential; 18.215 Site Plan Review; 18.245 Supplemental Development Standards; 18.250 Conditional Uses; 18.260 Variances; 18.275, Signs; 18.270; and Off-Street Parking and Loading.
