

CITY OF LA CENTER, WASHINGTON NOTICE of PUBLIC HEARING

Parking Code Updates (File #: 2022-028-ZON/SEPA)

The City of La Center is updating its code provisions pertaining to parking. The code update will primarily affect LCMC 18.280 (Off-street Parking and Loading), but provisions in other code chapters including LCMC 18.40 (Definitions), LCMC 18.140 (Medium Density Residential District), LCMC 18.158 (La Center Junction Plan Zoning District), 18.165 (Mixed-Use), and 18.245 (Supplementary Development Standards). If adopted, the code update would:

- Provide an applicability statement for the off-street parking code in LCMC 18.280 that clarifies that parking provisions apply to new development, expansions of existing development, new construction of a high valuation, when a parking lot is constructed, or when there is a change in use.
- Require variances for deviations from parking standards including quantity reductions of more than 15% or providing more parking than the maximum allowed.
- Prohibit parking of motor homes, recreational vehicles, boats, and utility trailers on street or in front of a house for more than 2 weeks per year.
- Changing the minimum number of off-street parking spaces for multifamily residential, industrial, and commercial uses to align with parking demand.
- Establishing a maximum number of parking spaces of 150% of the minimum in the Downtown Commercial, Downtown Overlay, and Mixed Use zoning districts and 200% in all other commercial and public districts.
- Allowing for parking reductions and credits up to 15% for provision of bike parking and for on- street parking in downtown La Center.
- Allowing for compact spaces to count for up to 20% of the total of the required number of spaces and requiring they be 8 feet wide by 15 feet long.
- Allowing for offsite parking within 300 feet for commercial and industrial uses.
- Eliminating redundant provisions of the code.
- Moving multifamily parking provisions to the Medium Density Residential (MDR-16) zoning district.
- Requiring landscaping islands every twelve spaces in parking lots.

The hearing will be held on Tuesday, September 13, 2022 beginning at 6:30 PM. The City has modified the hearing and public testimony procedures to meet the Hybrid Meeting requirements. The hearing will be conducted inperson at 210 E 4th Street La Center, WA 98629 and online via GoToMeeting (a video conferencing service). Participants do not need
