

<u>December 2022 – Reported Crimes</u>




December 2022 - Total Crimes Reported = 14




<u>December 2022 – Reported Arrests</u>




Total Arrests Reported – December 2022 = 4

Total Arrests Reported – December 2021 = 3(1) – DUI (2) - Other Offenses


December 2022 - Calls for Service



 - Domestic Violence Related Crimes Account for much of the Increase in Criminal Offenses from 2021 to 2022.
 - Increase In Vandalisms Attributed To Increase In Window Smashes On Vehicles To Gain Entry To Commit Theft.

Community Messaging

- The La Center City Hall still has wheel locks provided through an auto theft prevention grant from the State of Washington. We will continue to provide them free of charge to residents until the supply is exhausted.
- Popular Scams To Be Aware of:
 - Law Enforcement Scam Scammer will call impersonating a Law Enforcement Officer. They will tell the victim they have a warrant/or fine that needs to be paid and ask that you sent them money or be subject to arrest.
 - Sweepstakes and Lottery Scams Scammer will call an older adult and tell them they've won a lottery or prize of some kind. The victim is told to claim their winnings they must send money, cash, or gift cards up front to cover taxes and processing fees.
 - Grandparent Scam Scammers call a would-be grandparent and say something along the lines of: "Hi, Grandma, do you know who this is?" When the unaware grandparent guesses the name of the grandchild the scammer most sounds like, the scammer can instantly secure their trust. The fake grandchild then asks for money to solve some urgent financial problem (such as overdue rent, car repairs, or jail bond). They may beg the grandparent not to tell anyone. Since fraudsters often ask to be paid via gift cards or money transfer, which don't always require identification to collect, the older adult may have no way of ever recovering their money.
