



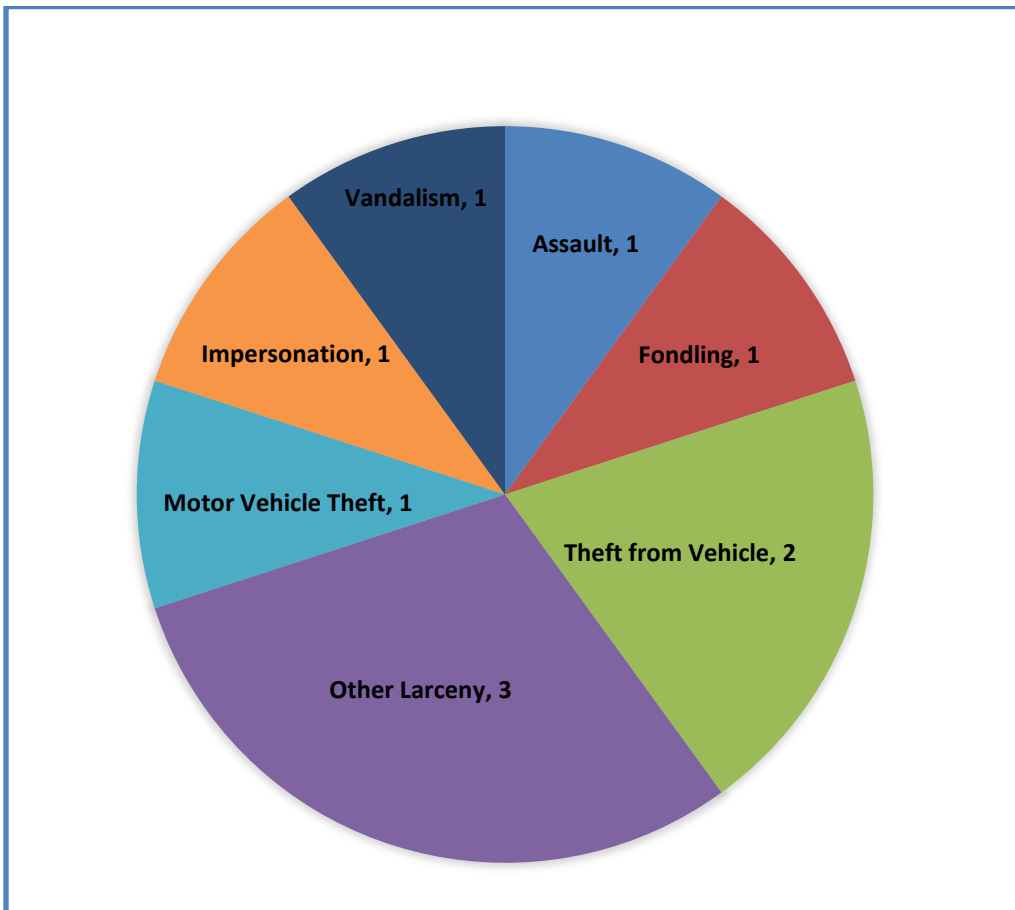

March 2023 – Total Crimes Reported = 10

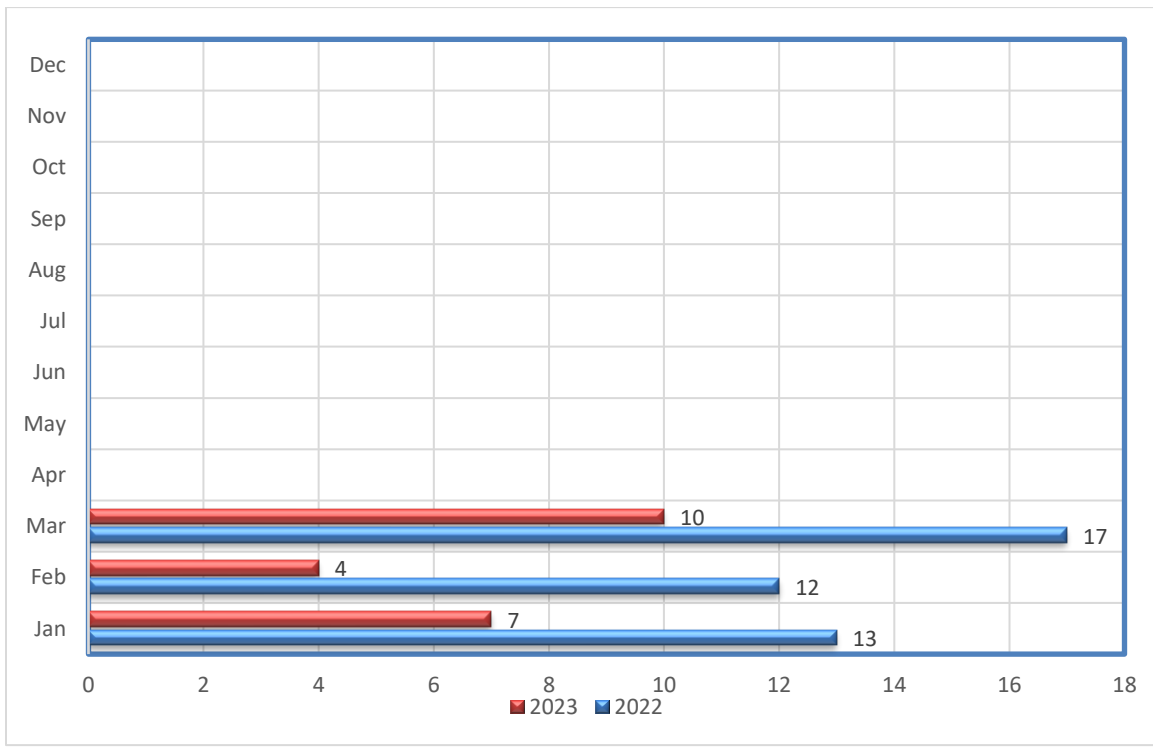
March 2022 – Total Crimes Reported = 17

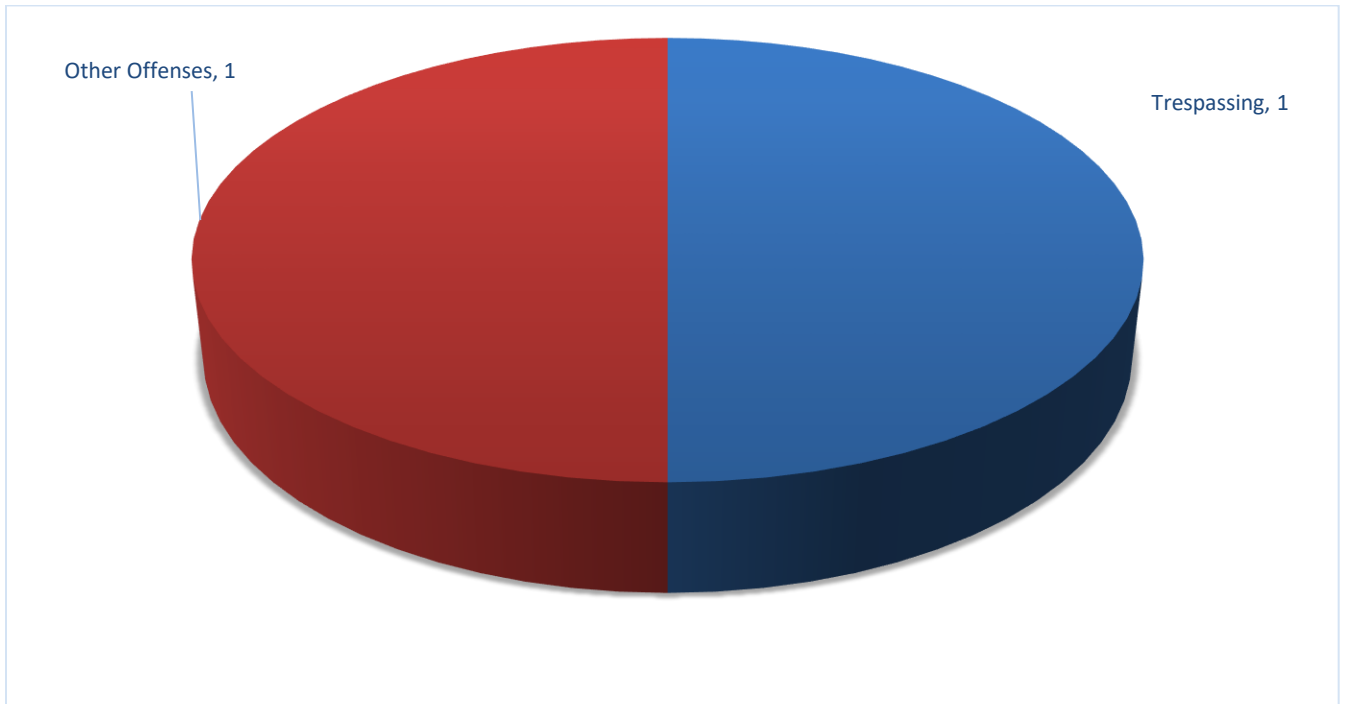

## Monthly Reported Crime Comparison 2022 Versus 2023



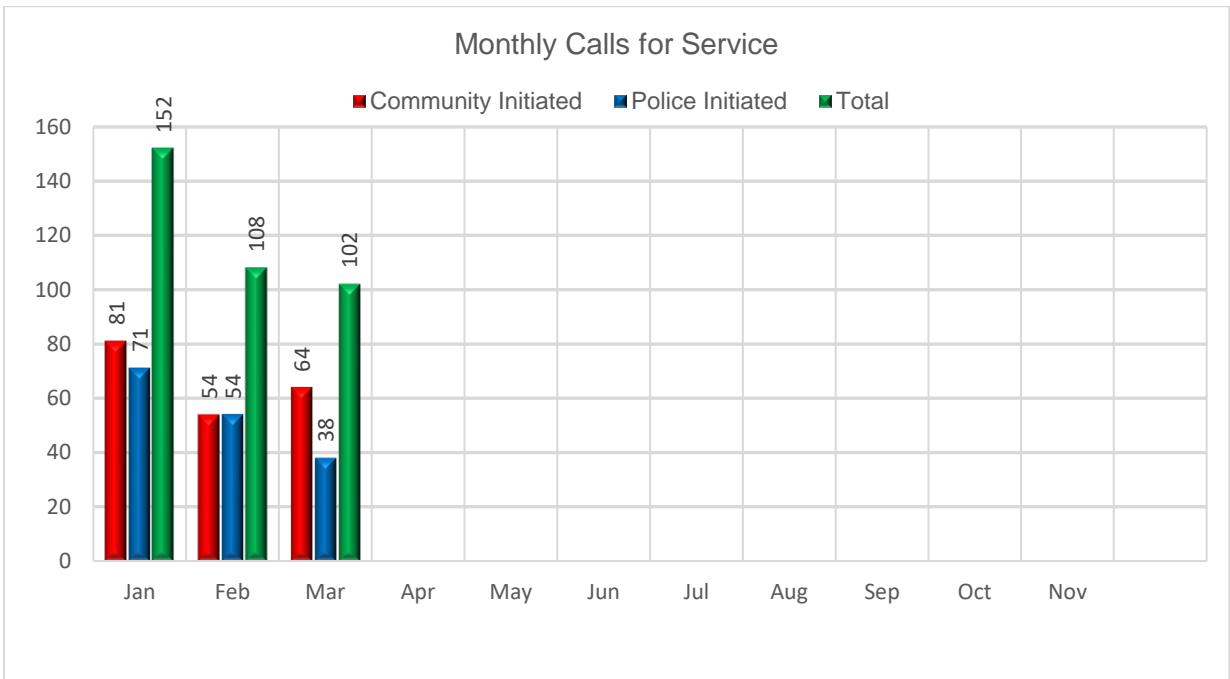
March 2023 – Reported Arrests



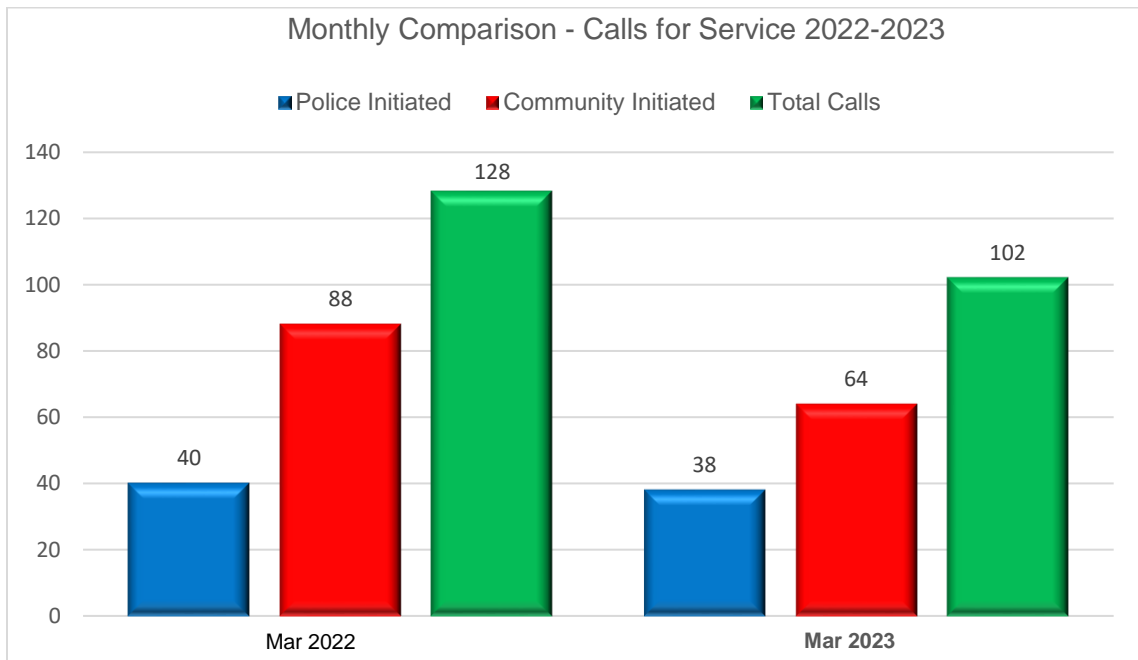
Total Arrests Reported – March 2023 = 2

Total Arrests Reported – March 2022 = 3

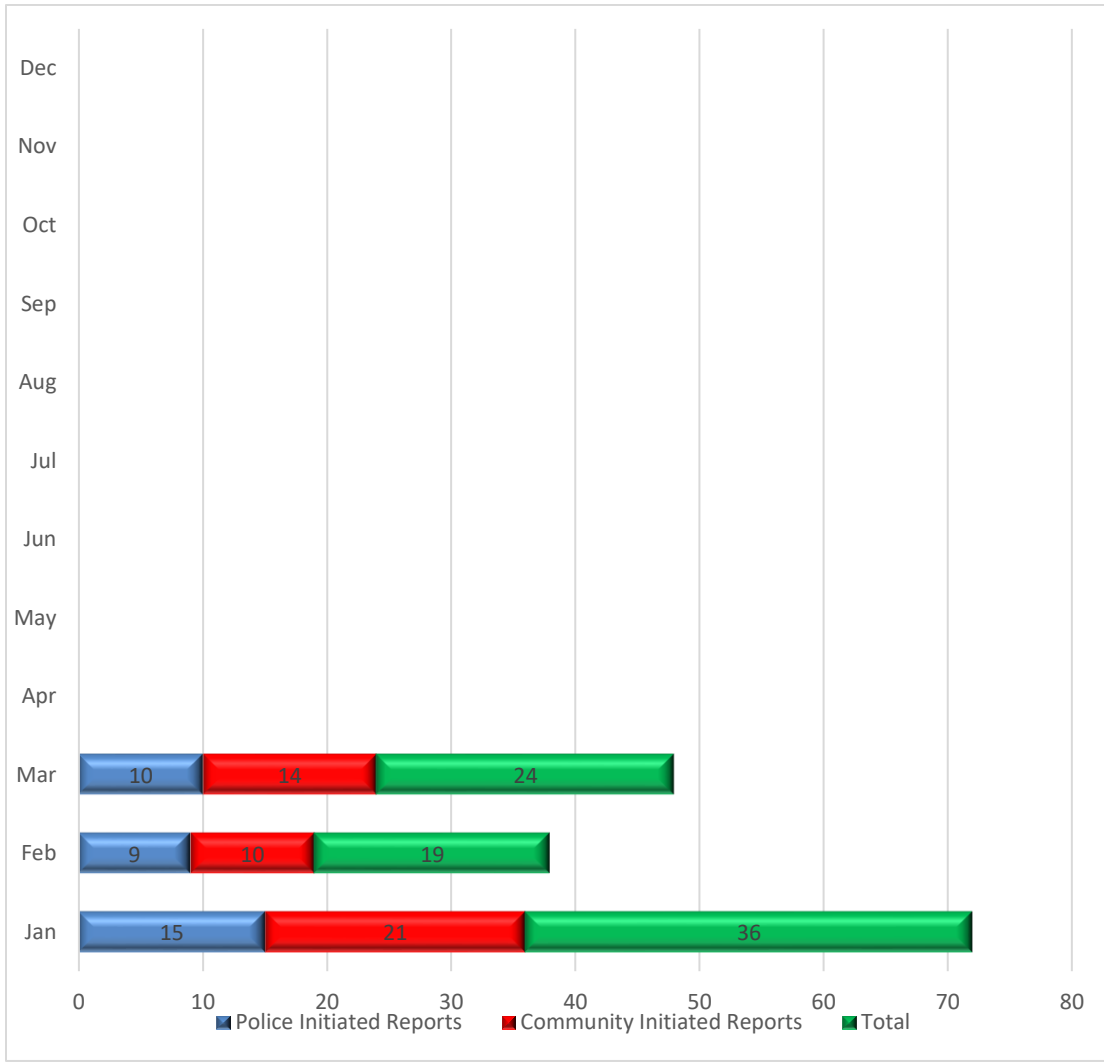
March 2023 - Calls for Service.
