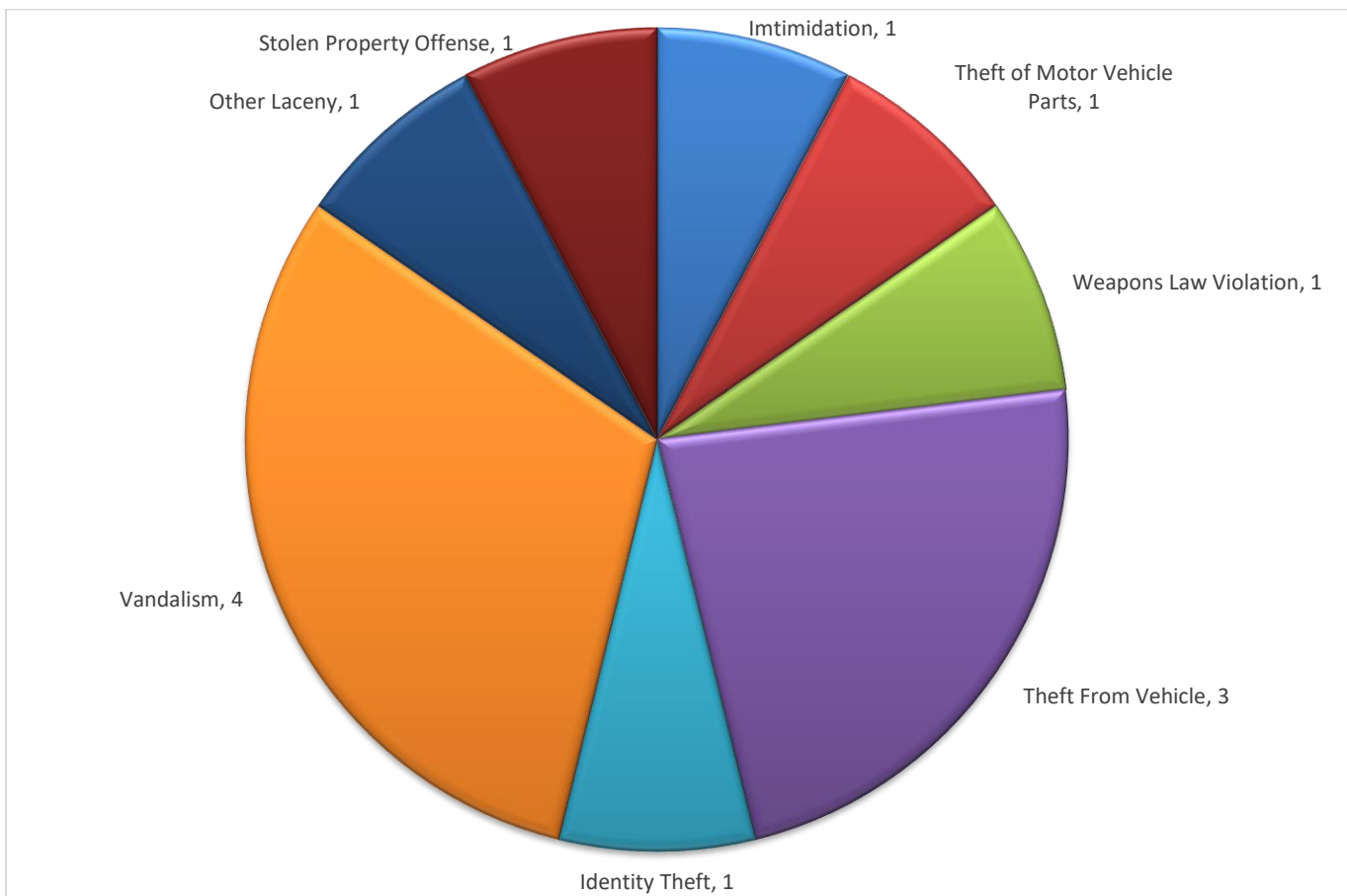

May 2022 – Total Crimes Reported =13

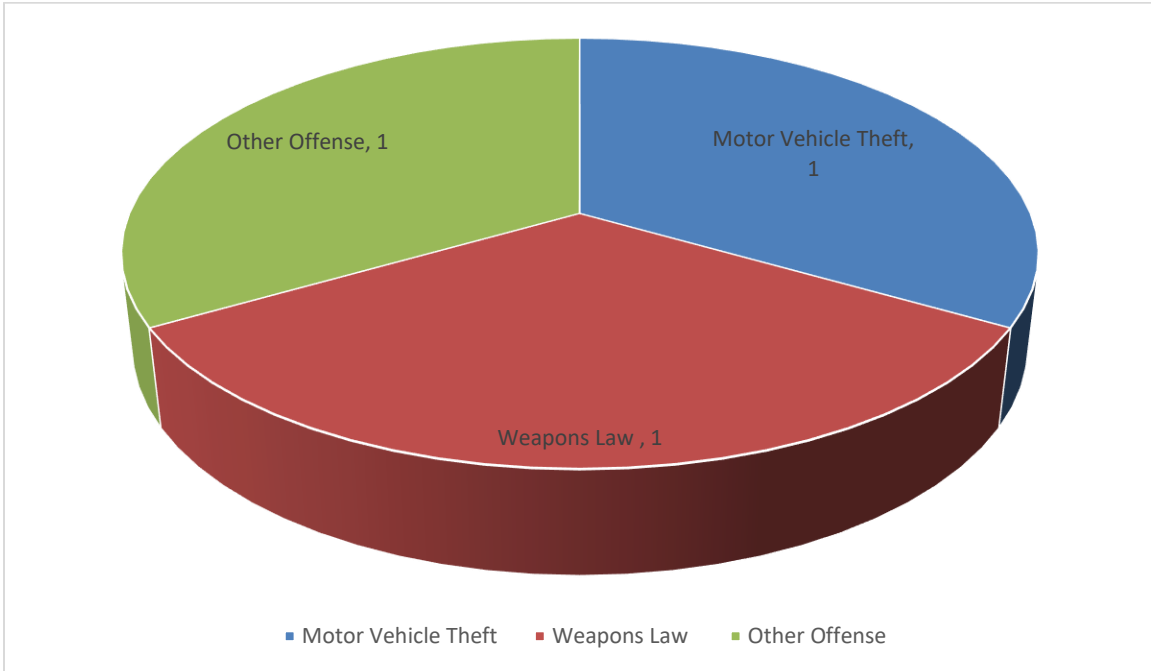
May 2021 – Total Crimes Reported = 15

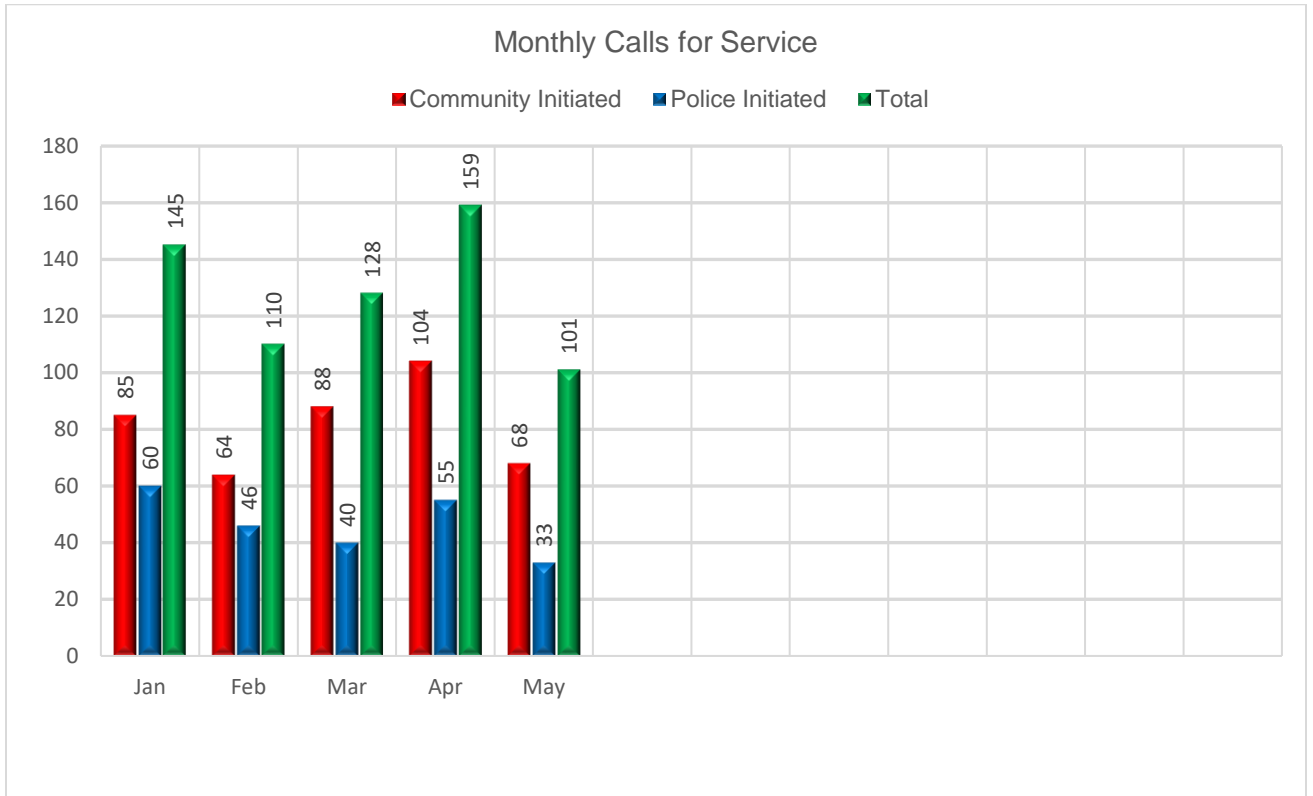

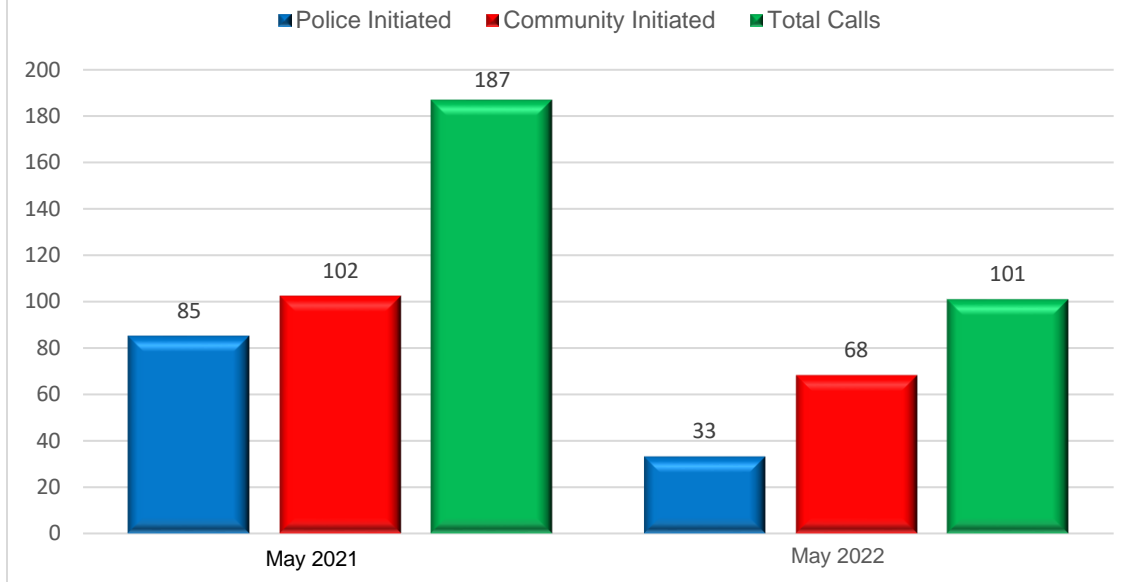

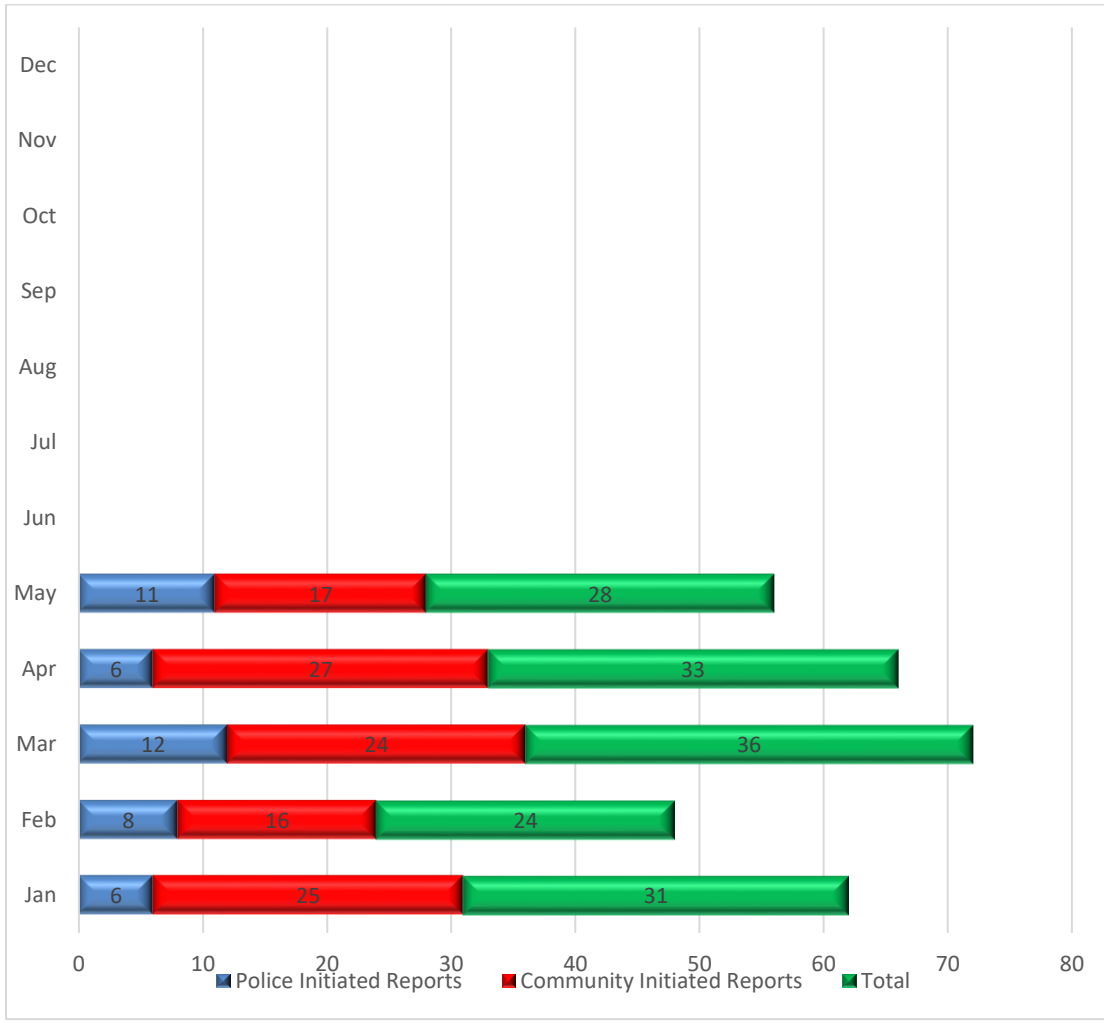
## May 2022 - Calls for Service
