Notice is hereby given that La Center, State of Washington, is accepting bids until 2:00 PM on Thursday June 13, 2024 via email at tcoleman@ci.lacenter.wa.us, or they can be hand delivered Attn: Tracy Coleman, Public Works and Community Development Director, 210 East 4th Street, La Center, Washington, 98629. An email receipt will be sent for those being sent via email. If you do not receive an email, your bid has not been received. The bid is for installing a 6-foot-high black vinyl chain-link 9-gauge fence with automatic 12-foot gate. The fenced area is approximately 350 linear feet of fencing and a 12-foot gate. Bids will be received until 2 p.m. on June 13, 2024.

This bid provides for complete installation of a black chain-link fence, six (6) feet in height of 9-gauge wire size, and inclusive of a manual man gate and a 12-foot-wide automatic vehicle gate. The automatic gate to be SOLAR with a hard wire option and 3-year warranty. Additionally, remove and replace approximately 38 feet of existing chain-link fence and replace it with 6' black vinyl chain-link. Tie into the building side to prevent side building access. This will be a lump sum bid. There is no Engineer's Estimate.

The contractor is required to attend a **mandatory site meeting**. The city is not responsible for verifying the quantity of material or linear feet of the area needing to be fenced to complete the job. Work to begin no later than July 8, 2024. Work to be completed within 15 working days from mutually agreed start date, yet no later than July 26, 2024.

Install 6' high black vinyl chain-link fencing with man gate near building entrance.

Install automatic 12-foot gate.

Remove approximately 38 linear feet of existing chain-link and replace with new.

Bid Documents: This is a lump sum bid inclusive of prevailing wage labor and all materials to complete the job. Bids must include the following line items:

- Mobilization
- Labor
- Removal and replacement of existing galvanized fencing (labor and materials)
- New Fencing Materials
- Gate Materials inclusive of SOLAR automatic gate that has hard wire option.
- Bond
- Tax
- Lump Sum Price

Each bid shall be accompanied by a bid bond in the sum of five (5%) percent of the bid amount. An acceptable performance bond in the amount of 100% of the contract price within ten (10) calendar days of the award. The City of La Center reserves the right to reject any and all bids and to accept the bid deemed most advantageous to the city and to waive all informalities in the bidding.
